Be it remembered the Mayor and Board of Aldermen of the Town of Carrollton was in session on Tuesday, October 4, 2011, 6:30 p.m.

A motion was made by Alderman Taylor, duly seconded by Alderman Lee and approved the amended agenda. The minutes of the September meeting were approved with corrections on a motion by Alderman Lee, seconded by Alderman Shook.

Galon Shumaker, Water Operator, gave a report to the Board on the water system. He stated he would be marking the water line on Hwy 82 since the phone company is laying new lines from Greenville to Columbus.

Under old business it was reported that Tommy Long has not finished his work and has not been in touch with Mr. Spradling.

Mrs. Wessie Gee appeared before the board asking for help in solving the problem of how people turn in and out on the side of her street onto Jackson Street. Board members stated they would look at it with her and try to come up with a solution.

Jerry Yates appeared before the Board stating he was buying a machine that would get the leaves out of the ditches. He stated he would be willing to do this during the winter months for the Town for approximately \$800.00 per month. He stated he could also clean out the ditches and drains. Alderman Taylor asked that Mr. Yates give a written proposal to the board and it would be taken under advisement.

Alderman Taylor asked that it be made a part of the minutes that the Fire Department brought their trucks and washed the streets down before the pilgrimage. He further stated that he felt because the firemen were not paid employees that the towns should go together and have a "Thank You for What you Do Dinner" This expense would come from contributions of the Board Members. Alderman Taylor is to talk with N. Carrollton and the fire department come up with a date for this dinner the early part of November.

Alderman Taylor also gave a report on the Pilgrimage, stating it was very successful and that 322 tickets had been sold.

Alderman Taylor also asked if the Town had an inventory of their furniture and fixtures. He was told we do not. He stated it was a state law and he felt that we should do this as soon as possible.

The Board Clerk asked if the Board wanted to advertise for a member of the CLG board since Anne Stokes has resigned. She was told to advertise this position in the Conservative on for three weeks and then accept application until the day of the next scheduled board meeting.

The Board Clerk also presented final revision on the 2010-2011 budgets for the Boards approval. A motion was made by Alderman Taylor, seconded by Alderman Lee and approved these revisions.

Alderman Sanders made a motion, seconded by Alderman Shook and approved to pay bills as read.

There being no further business to come before the Board a motion was made by Alderman Sanders, duly seconded by Alderman Wilson and approved to adjourn until Tuesday, November 1, 2011, at 6:30 p.m.
